If your group has a budget over \$100,000 and/or paid staff please explain why this funding is being requested. If your project is using a fiscal agent we only need to see your project budget.
3. If you are a non profit or a not for profit organization, you are required to attach copies of your Internal Revenue Service letter of determination of 501(c)(3) non-profit status or arrangements with a fiscal agent and their 501 (c)(3) status. We will not release funds until we have proof of 501 (c)(3) status.
